
- Reporting Requirement for CoC Grants (CoC grant recipients utilize the Sage HMIS Reporting Repository to complete Annual Performance Reports (APRs)
- Due 90 Days not 3 months after the Program Year Ends
- Must be submitted in the SAGE System
  - HUD does not see what the Grantee inputs until APR is submitted





# Sage APR & HMIS Lead

- HMIS is the source for many reports, including APRs
- Proper set up of data collection workflows in your HMIS software is crucial to accurate reporting
- Communicate with your HMIS System Lead or Administrator to ensure proper set up





# Things to pay attention to in SAGE

You have the ability to put comments in to support your program or reporting.

You can only report on eligible activities in your Grant (i.e., Operating, Leasing, Rental Assistance, Support Services, HMIS, Planning, and/or Administration)


Approval or Disapproval

### **APR Guides, Tools, and Webinars**

Recipients with HUD funding received through CoC homeless assistance grants (e.g., Supportive Housing Program, Shelter Plus Care, Section 8 Moderate Rehabilitation Single Room Occupancy Program, CoC Program) are required to submit an Annual Performance Report (APR) electronically to HUD every operating year. Data collection for the APR is aligned with the most recent version of the Homeless Management Information System (HMIS) Data Standards.

Prior to April 2017, APRs were submitted through *e-snaps*. All APRs that were not submitted in *e-snaps* by March 30, 2017 need to now be submitted in HUD's **Sage HMIS Reporting Repository**. *E-snaps* will remain open for recipients to revise or update APRs that they submitted in the system by March 30, 2017. ### Sage HMIS Reporting Repository

#### Annual Performance Reports (APRs)

In April 2017, HUD began requiring CoC homeless assistance grant recipients to submit their APR data through a new online system – the Sage HMIS Reporting Repository. Grantees will no longer submit APRs in e-snaps. This change in systems applies to all CoC homeless assistance grants regardless of when they were initially funded.

### ESG Consolidated Annual Performance and Evaluation Reports (CAPERs)

Beginning in October 2017, ESG recipients may submit their accomplishment data in Sage. This means that recipients will no longer need to use ESG-CAPER Annual Reporting Tool (eCart). Instead, project reports (Comma Separated Value (CSV) downloads) generated by HMIS or comparable databases can be uploaded directly into Sage.
