

THE PLAN TO END YOUTH HOMELESSNESS IN DALLAS & COLLIN COUNTIES

THE CHALLENGE: ADDRESSING YOUTH HOMELESSNESS

- Over the course of a year, ~1,150 youth and young adults experience literal homelessness in Dallas & Collin counties.
- The system lacks adequate shelter and rehousing resources, leaving many young people without stable, safe options.

THE SOLUTION: HOUSING FORWARD'S COORDINATED COMMUNITY PLAN

- A youth-centered, solution-focused approach that creates system-wide alignment by:
- Strengthening prevention & diversion to keep youth from becoming homeless.
- Enhancing existing shelters to provide 'no barrier' crisis interventions.
- Expanding housing options to provide safe, stable placements.
- **Enhancing wraparound services** like education, employment, and mental health care.

KEY COMPONENTS OF THE PLAN



1. The HUB: Centralized Youth Resource Center

- A one-stop hub offering assessments, housing navigation, and service connections.
- Provides diversion support & immediate assistance to prevent shelter entry.



2. Strengthened Prevention & Diversion Services

- Early interventions to keep youth from entering homelessness.
- Expanding family reunification efforts & financial assistance for at-risk youth.



3. Enhanced Supportive Youth Crisis Solutions

- Invest in **creating** ~170 new youth-dedicated shelter beds within existing shelter facilities, host homes, and motel vouchers.
- Emergency hoteling to provide immediate crisis response.



4. Expanded Permanent Housing Solutions

- **475 slots of Rapid Rehousing (RRH)** to assist youth in securing stable, independent housing.
- **150 units of Permanent Supportive Housing (PSH)** for those requiring long-term stability and services.

FUNDING BREAKDOWN

- Maximizes existing shelter efficiency each bed now serves 4-5 youth per year instead of 1-2.
- **Avoids trauma and costs of long shelter** stays by prioritizing permanent solutions.
- Ensures every youth has a clear pathway off the streets through prevention, rehousing, and supportive services.

HOW CAN I SUPPORT HOUSING FORWARD?

- Secure \$13.6M in funding to fully implement plan.
- Advocate for long-term investments in youth housing and support services.
- **Strengthen cross-sector collaboration** to sustain progress.
